Sub: - Complaint

Sir,

I ASI Bijoy Patar of Burdwan PS do hereby lodge this complaint against (1) Owner of vehicle no. WB-42AQ/4160 (2) Driver of vehicle no. WB-42AQ/4160, along with seized articles 1) One red colour Swift Dzire (Maruti Suzuki) four wheeler car bearing chassis no. MA3CZF03SJH398783, Engine No. D13A3374066 with number plate WB-24AV/0674. I beg to state that on 29/05/2021 received an e-mail from applicant Swami Saradatmananda, General Secretary of Sree Sree Ramkrishna Ashram, 2 no P.K. Saha Lane, PS- Baranagar, Kolkata- 36 that on 28/05/2021 he received a phone call from one Bipad Taran (Mob No. 9735195863/7908100321), who disclosed that he was calling from Beekay Auto Pvt. Ltd. and stated that the vehicle of him (Swami Saradatmananda) has been serviced. On reply applicant stated that their car was kept at Garage of Baranagar Ashram. Applicant was informed that the car bearing no. WB-24AV/0674 was left at the service center for servicing.

As per order of I/C Burdwan PS, myself left PS to enquire into this matter, vide Burdwan PS GD Entry no. 2628 dt. 31/05/2021. At around 08.45 hrs, I reached at Beekay Auto Pvt. Ltd. and make enquiry into this matter. It came to know that on 28/05/2021, someone deposited the car no. WB-24AV/0674 for servicing. On physical verification it came to know that engine no. and chassis no. of deposited car belongs to vehicle vide Reg. No. WB-42AQ/4160. So, it is clear that the driver and owner, who deposited the car has changed the number plate with original one for any fraudulent means. Accordingly I seized the car under proper seizure list.

Hence, it is reasonable believe that owner and driver of vehicle no. WB-42AQ/4160, forged and makes false property mark in respect of the number plate, for the purpose of harming reputation and any other means. So, I pray that a case may kindly be started under proper section of law against (1) Owner of vehicle no. WB-42AQ/4160 (2) Driver of vehicle no. WB-42AQ/4160 and arrange for its investigation.
