Sub: Complaint

Sir,

In producing herewith arrested accused persons namely (1) Firoj Sk (34 yrs) S/o Sk Sukur of Bajeprotappur, Dangapara A/P- C/o. Sirajul Mallick of Khalerpool, Machkhanda, PS-Khandaghosh, Dist-Purba Bardhaman (2) Dinesh Dutta @ Chotton (51 yrs) S/o Late Ganesh Dutta of Kanainatshal, Police Line and (3) Tagar Sk @ Sagar (23 yrs) S/o Mustafa Sk of Saraitikor, Malpara all are PS-Burdwan, Dist- Purba Bardhaman and seized articles (i) 01 piece Iron Rod (length approx 3.5 Ft), (ii) 01 piece Lathi (length approx 4Ft) and (iii) 01 Piece Bhojali (length approx 1 and ½ Ft) along with seizure list, memo of arrest, I ASI Bijoy Kumar Patar of Burdwan PS do hereby lodged this complaint to the effect that on 25/09/2020 at 00.25 hrs, ASI Jayanta Kr. Das, duty officer of Burdwan PS received an information over telephone from a reliable source that some persons were assembled near SAI-Complex on Burdwan-Gushkara road (NH-2B) to commit crime on running vehicles at that area. Accordingly he informed the matter to I/C Burdwan PS and diarised the matter vide Burdwan PS GDE No- 2550 Dt- 25/09/2020. At 00.30 hrs, when Myself along with C/2109 Sayed Nasikul Islam and HG-810 Sk Sabir Ali were performing mobile patrolling duty near Saraitikor more, the duty officer of Burdwan P.S. informed me about the matter and as per direction of I/C Burdwan PS, I along with my accompany force and another mobile officer SI Sadhan Ch. Patra and his accompany force left for that place to work out the information.

At about 00.50 hrs, we reached near SAI-Complex on Burdwan-Gushkara road (NH-2B) and left our vehicle at a considerable distance and proceed towards the assembled place on foot concealing our presence and with the help of scattered light of running vehicle we noticed that 10-11 persons were assembled on the road side area. As such we proceed towards the assembled place dividing us in two groups. As soon as we reached at the spot they tried to flee away on seeing arrival of police party, but we managed to apprehend 03 persons, while rest 7-8 persons fled away in the darkness. On interrogation those persons disclosed their identity as above and made contradictory statemenr. regarding their presence at that time. On suspicion we searched them and recovered the following articles from their exclusive possession as noted against below:-

I) 01 piece Iron Rod was recovered from the exclusive possession of accused Firoj Sk which was on his right hand.

II) 01 piece Lathi was recovered from the exclusive possession of accused Dinesh Dutta @ Chotton which was on his right hand.

III) 01 Piece Bhojali was recovered from the exclusive possession of accused Tagar Sk @ Sagar which was on his right hand.

On being asked, the above noted accused persons confessed that they assembled there and making preparation for committing crime over the factory. So, all the articles were seized under proper seizure list duly signed by the accused persons and witnesses in between 01.40 hrs. and 02.05 hrs, also label were prepared and pasted the same on its respective seized articles. As it was dead hour of night no local witnesses were found at that place. Accordingly I, arrested them being issued Memo of arrest at 02.10 hrs.

I, therefore, pray before you that a case U/S- 399/402 IPC may kindly be started against arrested accused persons namely (1) Firoj Sk (34 yrs) S/o Sk Sukur of Bajeprotappur, Dangapara A/P- C/o. Sirajul Mallick of Khalerpool, Machkhanda, PS-Khandaghosh, Dist-Purba Bardhaman (2) Dinesh Dutta @ Chotton (51 yrs) S/o Late Ganesh Dutta of Kanainatshal, Police Line and (3) Tagar Sk @ Sagar (23 yrs) S/o Mustafa Sk of Saraitikor, Malpara all are PS- Burdwan, Dist- Purba Bardhaman and 7-8 others fled away accused persons and arrange for its investigation.

On return to PS, I, the complainant, drafted and prepared the complaint through PS computer.
