Sir,

In producing herewith arrested accused persons namely (1) Rintu Khan (26 yrs) S/o Ainamul Khan of Munshipara, (2) Nobirul Sk (24 yrs) S/o Sadek Sk of do, (3) Mostafa Sk (32 yrs) S/o Sintu Sk of Dinigram, (4) Chand Md. (18 yrs) S/o Mazbur Sk of Munshipara, (5) Rabiul Hoque (39 yrs) S/o Sekendar Badsha of Bahadurpur, (6) Idul Sk (26 yrs) S/o Bazrul Sk of do, (7) Yadul Islam (36 yrs) S/o Abdul Mannan of Khidirpur, Chabghati, (8) Gajiruddul Sk (22 yrs) S/o Manik Sk of Kayadanga, (9) Barkat Khan (18 yrs) S/o Noor Alam Khan of Munshipara and (10) Sisir Kr. Das (28 yrs) S/o Santosh Kr. Das of Vill & PO- Maheshil all are PS- Suti, Dist- Murshidabad, along with seized article i) one ambulance bearing no. WB-07J/7733, I, ASI Tapas Kr. Hazra of Burdwan PS do hereby lodge this complaint against the above noted persons to the effect that today (05/08/2021) in course of my duty, I was performing NAKA checking at Curzon Gate at 14 15 hrs for checking of vehicle etc. C/1318 Bivas Dhara and NVF- Rafiqul Molla of Burdwan PS were accompanying me vide Burdwan PS GDE No- 537 Dated- 05/08/2021.

During that period, I intercepted one ambulance bearing no. WB-07J/7733. It was noticed that driver along with 9 passengers inside the ambulance were without mask. Those persons were asked about reason behind traveling in the ambulance in a congested manner. They stated that they are working as labour in a construction site at Kolkata. On demand, those persons disclosed their identity and notice that all were coming from Suti PS area under Murshidabad district. On being asked, at first the driver refused to give his particulars and did not produced necessary documents for the purpose of his travel in the ambulance. The passengers of the vehicle stated that the driver belongs to their area and today when they were trying to board a bus for Kolkata, at that time the driver offered them to carry them in his ambulance. As per Govt. Circular no. 753/IV-ISS/2M-22/2020 Dt. 29.07.2021, it is mandatory to wear mask in public places and there is need to keep safe distance during travel. So, I arrested them for violating provision of Sec 188 IPC and Sec 51(b) Disaster Management Act, 2005. The driver namely Sisir Kr. Das, later disclosed his identity and was arrested under same section of law apart from Section 202 M.V. Act. Issued arrest memo against all the arrested accused persons and briefed them ground of arrest.

So, after return at PS I drafted this complaint at PS computer and request before you that a case U/s-188 IPC and Sec 51(b) Disaster Management Act, 2005 and 202 M.V. Act. may kindly be started against arrested accused persons namely (1) Rintu Khan (26 yrs) S/o Ainamul Khan of Munshipara, (2) Nobirul Sk (24 yrs) S/o Sadek Sk of do, (3) Mostafa Sk (32 yrs) S/o Sintu Sk of Dinigram, (4) Chand Md. (18 yrs) S/o Mazbur Sk of Munshipara, (5) Rabiul Hoque (39 yrs) S/o Sekendar Badsha of Bahadurpur, (6) Idul Sk (26 yrs) S/o Bazrul Sk of do, (7) Yadul Islam (36 yrs) S/o Abdul Mannan of Khidirpur, Chabghati, (8) Gajiruddul Sk (22 yrs) S/o Manik Sk of Kayadanga, (9) Barkat Khan (18 yrs) S/o Noor Alam Khan of Munshipara and (10) Sisir Kr. Das (28 yrs) S/o Santosh Kr. Das of Vill & PO- Maheshil all are PS- Suti, Dist- Murshidabad.
