Sir,

In producing herewith arrested accused person namely Asgar Ali Sk (44 yrs) S/o Late Sowkat Ali Sk of Balisha, Bhandardihi, PS- Dewandighi, Dist- Purba Bardhaman along with seized articles of 08 Kg Fire Crackers of different brand along with seizure list, memo of arrest, I SI Sanjay Mondal of Burdwan PS do hereby lodge this complaint to the effect that on 19/11/2020 at 14.05 hrs, I along with C/1140 Biswajit Pal and C/1592 Md. Safiulla both of Burdwan PS out from Burdwan P.S. vide Burdwan P.S. GD Entry No. 1849 dt- 19/11/2020 for mobile patrolling duty.


In course of my mobile patrolling duty at 16.55 hrs, when ever at Birhata, I received source information that one person selling Fire Crackers keeping on footpath by road side near Jotshna Store at Tentultala Bazar, Burdwan. On getting this information, I informed the matter to I/C Burdwan P.S. and as per his order, I along with my accompany force had been to Jotshna Store at Tentultala Bazar, PS- Burdwan, Dist- Purba Bardhaman to work out the information.

At about 17.10 hrs. we reached at there and left our vehicle at road side and proceed towards said place on foot. As soon as we reached at the spot and found that one person was selling Fire Crackers of different brand keeping on footpath on a side of a road. He kept the same without any precaution of safety of Fire and violating the order of Hon'ble High Court, Calcutta. On demand in support of the said Fire Crackers, he failed to produce any kind of valid documents or valid license. On being asked, he disclosed his identity as above noted. So there is maximum chance of loss of human life and properties at congested area. On asking he confessed that he procured the huge quantity of Fire Crackers from Durgapur and storage for selling during Puja festivals times in the open market for his wrongful gain. So, I seized the above mentioned fire crackers under proper seizure list duly signed by the accused person and witnesses in between 17.50 hrs. and 18.20 hrs. Accordingly I, arrested him being issued Memo of arrest at 18.25 hrs.

I, therefore, pray before you that a case U/s- 188/286 IPC & 24 West Bengal Fire Service Act may kindly be started against arrested accused person namely Asgar Ali Sk (44 yrs) S/o Late Sowkat Ali Sk of Balisha, Bhandardihi, PS- Dewandighi, Dist- Purba Bardhaman and arrange for its investigation.
