Sir,

In producing herewith arrested accused person namely Amarjit Paswan (39 yrs) S/o Late Srilal Paswan of Telipukur, Puratan Bazar, PS- Burdwan, Dist- Purba Bardhaman along with seized articles i) 20 Bottles x 600 ml Country Sprit Styled as CAPTAIN, and ii) 10 ltrs of ID liquor contains in 01 polythene packet (375 ml sample was taken in a bottle) along with seizure list, memo of arrest, I ASI Jayanta Kr. Das of Burdwan PS do hereby lodged this complaint to the effect that on 29/05/2021 at 13.55 hrs, I along with C/3078 Nimai Ch. Sinha and HG-703 Rajabrata Chatterjee both of Burdwan PS out from Burdwan P.S. vide Burdwan P.S. GD Entry No. 2459 dt- 29/05/2021 and Burdwan PS C.C. No. 2625/21 dt. 29/05/2021 for Mobile Patrolling Duty.

In course of Mobile Patrolling duty at 18.50 hrs, I received source information that one Amarjit Paswan stocked huge quantity of Country Sprit and ID liquor in his house at Telipukur, Puratan Bazar, Burdwan and selling the same. On getting this information, I informed the matter to I/C Burdwan P.S. and as per his order, I along with my accompany force had been to Telipukur, Puratan Bazar, PS- Burdwan, Dist- Purba Bardhaman to work out the information.

At 19.10 hrs we reached at Telipukur, Puratan Bazar, PS- Burdwan, Dist- Purba Bardhaman and parked our vehicle. Later proceed towards the house of the accused person earmarked by our source. After we reached there, we surrounded the said house and entered into house premises, found one person was trying to flee away, but we apprehended him. On being asked, he disclosed his identity as noted above and he made contradictory statement about reason behind ran away. I searched inside his house & recovered the above articles from his house. On being demand, he failed to produce any valid license/papers in respect of above Country Sprit and ID liquor. He also disclosed that he stocked the above articles for selling illegally for wrongful gain. So, the above noted accused person committed an offence u/s- 46 B.E. Act. So, I seized those aforementioned articles under proper seizure formalities and label. Seizure formalities were done in-between 19.55 hrs. and 20.20 hrs. Accordingly, I arrested said accused person being issued Memo of arrest at 20.25 hrs.

So, I pray before you that a case U/S- 46 B.E. Act may kindly be started against accused Amarjit Paswan (39 yrs) S/o Late Srilal Paswan of Telipukur, Puratan Bazar, PS- Burdwan, Dist- Purba Bardhaman and arrange for its investigation.

On return to PS, I drafted and prepared the complaint through PS computer.
