Sir,

In producing herewith arrested accused persons namely (1) Saidulla Mallick (30 yrs) S/o. Lt. Azijul Mallick of Nowapara, Paschimpara, PS-Mongalkote, Dist-Purba Bardhaman, 2) Sk Ahamed (22 yrs) S/o. Mujad Sk of do, 3) Sk Hasmat @ Kori (28 yrs) S/o. Sk Asgar of do, 4) Hiramohan Mallick (27 yrs) S/o. Lalmohan Mallick of Kestopur Baganpara, 5) Sk Sabir @ Kantal (21 yrs) S/o Md Ashik of Khagragarh, 6) Rahamat Sk @ Angur (25 yrs) S/o Alam Sk of Badsahi Road, Mathpara, (7) Sk Asraful @ Raja (19 yrs) S/o Sk Sadoruddin of Hatudewan, Pirtala, all are PS- Burdwan, Dist- Purba Bardhaman and seized articles (i) 01 Piece Bhojali (length approx 1 and ½ Ft) (ii) 01 piece Iron rod (length approx 03 ft), (iii) 01 piece Bamboo sticks (length approx 04 ft), (iv) 01 piece Iron rod (length approx 03 ft), (v) 01 piece Bamboo sticks (length approx 04 and 1/2 ft), (vi) 01 Piece Bhojali (length approx 1 and ½ Ft), (vii) 01 pce Nylon rope (length approx 25 ft), (viii) 01 four wheeler vehicle bearing Reg. No. WB-42M/9595 (TATA Indica white colour) with seizure list, memo of arrest, I SI Sk Abul Khayer of Burdwan PS do hereby lodged this complaint to the effect that on 05/08/2021 at 00.45 hrs, ASI Goutam Halder, table duty officer of Burdwan PS received an information over telephone from a reliable source that some persons were assembled near Srikrishna Cold Storage, Goda, nearby NH-2 (Durgapur to Kolkata Road) to commit crime on running vehicles at that area. Accordingly he informed the matter to I/C Burdwan PS and diarised the matter vide Burdwan PS GDE No- 474 Dt- 05/08/2021. At 00.50 hrs, when Myself along with C/973 Durga Sarkar and HG-812 Sk Saddam Hossain both of Burdwan PS were performing night patrol duty near Lakuddi, the duty officer of Burdwan P.S. informed me about the matter and as per direction of I/C Burdwan PS, I along with my accompany force and another mobile officer ASI Tapas Kr. Hazra and his accompany force left for that place to work out the information.

At about 01.15 hrs, we reached near Srikrishna Cold Storage, Goda, nearby NH-2 (Durgapur to Kolkata Road) and left our vehicles and proceed towards the assembled place on foot concealing our presence and with the help of scattered light of running vehicle we noticed that that 20-25 persons were assembled on the road side area. As such we proceed towards the assembled place dividing us in two groups. As soon as we reached at the spot they tried to flee away on seeing arrival of police party, but we managed to apprehend 07 persons, while rest 13-14 persons fled away in the darkness. On interrogation those persons disclosed their identity as above and made contradictory statement regarding their presence at that time. On suspicion we searched them and recovered the following articles:-

- I) 01 pce Bhojali was recovered from the exclusive possession of accused Saidulla Mallick which was on his right hand.
- II) 01 pce Iron rod was recovered from the exclusive possession of accused Sk Ahamed which was on his right hand.
- III) 01 pce Bamboo stick was recovered from the exclusive possession of accused Sk Hasmad @ Kori which was on his right hand.
- IV) 01 pce Iron rod was recovered from the exclusive possession of accused Hiramohan Mallick which was on his right hand.
- V) 01 pce Bamboo stick was recovered from the exclusive possession of accused Sk Sabir @ Kantal which was on his right hand.
- VI) 01 pce Bhojali was recovered from the exclusive possession of accused Rahamat Sk @ Angur which was on his right hand.
- VII) 01 pce Nylon rope was recovered from the exclusive possession of accused Sk Asraful @ Raja which was on his right hand.
- VIII) 01 four wheeler vehicle bearing Reg. No. WB-42M/9595 (TATA Indica white colour) which lying at PO.

On being asked, the above noted accused persons confessed that they assembled there and making preparation for committing crime over running vehicle and they also stated that said seized vehicle bearing Reg. No. WB-42M/9595 they used for the purpose of crime. So, all the articles were seized under proper seizure list duly signed by the accused persons and witnesses in between 01.45 hrs. and 02.30 hrs, also label were prepared and posted the same on its respective seized articles. As it was dead hour of night no local witnesses were found at that place. Accordingly I, arrested them being issued Memo of arrest at 02.40 hrs.

I, therefore, pray before you that a case U/S- 399/402 IPC may kindly be started against arrested accused persons namely (1) Saidulla Mallick (30 yrs) S/o. Lt. Azijul Mallick of Nowapara, Paschimpara, PS-Mongalkote, Dist-Purba Bardhaman, 2) Sk Ahamed (22 yrs) S/o. Mujad Sk of do, 3) Sk Hasmad @ Kori (28 yrs) S/o. Sk Asgar of do, 4) Hiramohan Mallick (27 yrs) S/o. Lalmohan Mallick of Kestopur Baganpara, 5) Sk Sabir @ Kantal (21 yrs) S/o Md Ashik of Khagragarh, 6) Rahamat Sk @ Angur (25 yrs) S/o Alam Sk of Badsahi Road, Mathpara, (7) Sk Asraful @ Raja (19 yrs) S/o Sk Sadoruddin of Hatudewan, Pirtala, all are PS- Burdwan, Dist- Purba Bardhaman and 13-14 others fled persons and arrange for its investigation.

On return to PS, I, the complainant, drafted and prepared the complaint through PS computer.
