Sir,

In producing herewith arrested accused persons namely (i) Mujibar Sk @ Chandan Sk (27 yrs) S/o Hannan Sk of Kalyanpur, PS-Aushgram, Dist-Purba Bardhaman, driver of truck bearing regn. no. WB-19J/3916, (ii) Choudhury Yadav (42 yrs) S/o Ribu Yadav of Vill-Bagra, PS-Chandan, Dist-Banka, Bihar driver of truck bearing regn. no WB-76B/0699, (iii) Tarakeswar Yadav (40 yrs) S/o. Balli Yadav of Vill-Eliashpur, PS-Manjir, Dist-Chapra, Bihar, driver of truck bearing regn. no. WB-19G/8678 along with seized articles (i) one truck bearing regn. no. WB-19J/3916 loaded with sand, (ii) one truck bearing regn. no WB-76B/0699 loaded with sand, (iii) one truck bearing regn. no WB-19G/8678 loaded with sand I, SI Chinmoy Banerjee of Burdwan PS do hereby lodge this complaint to the effect that on 12/06/2021 at 21.40 hrs. myself along with C/2530 Samir Kr. Tah and HG/188 Bikash Ch. Dey both of Burdwan P.S. were performing mobile patrolling duty at PS area vide Burdwan PS GDE No- 1126 Dt- 12/06/2021 and CC No. 2921/21 dated- 12/06/2021.

In course of mobile patrolling duty on 13.06.21 at 04.05 hrs, I have detained 03 sand loaded trucks at Mirchoba, Near Damodar Cold Storage on Kolkata Bound NH2, which was coming from Galsi side. On being asked, they disclosed their identity as above and stated that they are driver of the above noted vehicles. I asked them to produce documents in favour of loaded sand, but they failed to produce any supporting documents in support of loaded sand. Then they were asked to produce papers of the truck they were driving but again they could not. On interrogation, they made contradictory statements regarding procurement of loaded sand and its destination. So, it is reasonable believe that the above accused persons and others procured the said sand and truck either by theft or any illegal means for selling the same, in connivance with the owner of the said trucks.

Hence, I seized the above noted 03 trucks loaded with sand under proper seizure list. Accordingly, I arrested above persons after observing all formalities of arrest.

Therefore, I, pray a specific case under section 379/411/413/120B IPC may kindly be registered against (i) Mujibar Sk @ Chandan Sk (27 yrs) S/o. Hannan Sk of Kalyanpur, PS-Aushgram, Dist-Purba Bardhaman, (ii) Choudhury Yadav (42 yrs) S/o. Ribu Yadav of Vill-Bagra, PS-Chandan, Dist-Banka, Bihar, (iii) Tarakeswar Yadav (40 yrs) S/o. Balli Yadav of Vill-Eliashpur, PS-Manjir, Dist-Chapra, Bihar (iv) Owner of truck bearing regn. no. WB-19J/3916, (v) Owner of truck bearing regn. no. WB-76B/0699, (vi) Owner of truck bearing regn. no. WB-19G/8678 and arrange for its investigation.

On return to PS, I drafted and prepared the complaint through PS computer
