Respected Sir,

I, Sunanda Sankar, daughter of late-Sujit Sankar, residing at 2 No Shankari Pukura, P.O-Sripally, P.S- Bardhaman Sadan, Dist- Purba Bardhaman, am a student of B.E.A (St. Xavier's college Bardhaman). My Grand father late- Sachindra Lal Sankar was an employee in "Indian Army", Designation- "Subedar Major". Unfortunately, he was missing since 1970. For this reason Hon'ble Eastern command, Govt of India, allotted us a tea stall at Court Compound, Purba Bardhaman. My father and my uncle run-on the tea-stall for last 45 years. But on 01-05-2021 some anti-social destroyed our tea stall and threaten us over telephone if we re-open the tea stall they would kill everyone in our family as because my father supported BJP. After that incident, my father and my mother lodge a General Diary vide NO 158 Dated on 03-05-2021 at Bardhaman Sadan police station. Unfortunately, my father had passed away on 22-05-2021 at 12.15 PM. After my father's funeral ceremony, my uncle re-open the tea stall even after receiving so many so many threats just to feed us. But the anti-social activities doesn't stop here. After, reopening the tea stall my uncle get many threats and anti-social people placed two new stall on 13-06-2021 in between our tea stall. Now, in our stall we don't have any place for our customers.

It is sorry to say that above-mentioned Tea Stall is the only source of income for my family. Now, the anti-social people constantly threats my uncle if we take any step for our tea stall, they would kill him also. In absence of my father there is no source of income for my family except from the tea stall by which my uncle feed us, as well as look after my family.

Hence, you are hereby earnestly requested to take necessary step by which my uncle can run the tea-stall peacefully at court compound at Purba Bardhaman to save my family and obliged.
