Sir,

In producing herewith arrested accused persons namely (1) Md. Firdose (32 yrs) S/o Md. Isrile of Dubrajdighi, (2) Sk Anowar (32 yrs) S/o Sk Lokman of Khagraghar, (3) Santosh Ghosh (64 yrs) S/o Late Niranjana Ghosh of Baburbag, Chanditala, (4) Tapas Samanta (32 yrs) S/o Botokrishna Samanta of Aludanga, Ghoshpara and (5) Bablu Soren (27 yrs) S/o Late Shibal Soren of Traffic Colony, all are PS- Burdwan, Dist- Purba Bardhaman along with memo of arrest, I, ASI Jayanta Kr. Das of Burdwan PS do hereby lodge this complaint against the above noted persons to the effect that today (12.08.2021) in course of my duty, I had been to Curzon Gate at 21 05 hrs for checking of vehicle etc. C/3142 Israfil Sk and HG-774 Sanjay Kr. Roy both of Burdwan PS were accompanying me vide Burdwan PS GDE No- 1399 Dated- 12.08.2021 and Burdwan PS CC No. 4355 Dated- 12.08.2021.

In the long period at that place, I detained the above noted persons who were coming from either Tinkonia side or Birhata side. On being asked they disclosed their identity as above and I asked their whereabouts and reason behind their movement after night curfew from 21.00 hrs. But they could not supply any positive reply in support of their stand. As in this pandemic situation all movement are restricted after 21.00 hrs except emergency or essential service, which has been campaigning everywhere and everyday by administration, but these persons disobey the rule. As per Govt. Circular no. 753/IV-ISS/2M-22/2020 Dt. 29.07.2021, there is strict restriction in movement between 21.00 hrs to 05.00 hrs. So, I arrested them for violating provision of Sec 188 IPC and Sec 51(b) Disaster Management Act, 2005. Issued arrest memo against all the arrested accused persons and briefed them ground of arrest.

So, after return at PS I drafted this complaint at PS computer and request before you that a case U/s-188 IPC and Sec 51(b) Disaster Management Act, 2005 may kindly be started against arrested accused persons namely (1) Md. Firdose (32 yrs) S/o Md. Isrile of Dubrajdighi, (2) Sk Anowar (32 yrs) S/o Sk Lokman of Khagraghar, (3) Santosh Ghosh (64 yrs) S/o Late Niranjana Ghosh of Baburbag, Chanditala, (4) Tapas Samanta (32 yrs) S/o Botokrishna Samanta of Aludanga, Ghoshpara and (5) Bablu Soren (27 yrs) S/o Late Shibal Soren of Traffic Colony, all are PS- Burdwan, Dist- Purba Bardhaman.
